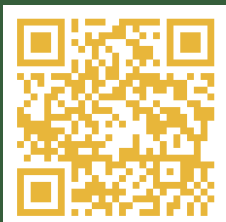

Message from the Board

The Frankfort Community Foundation Board would like to close 2025 by expressing appreciation to the individuals and organizations who supported our work throughout the year.

We were pleased to again receive a grant from The Patterson Foundation. Funds from the prior year's grant were used to complete repairs to the Frankfort City Pool waterslide in the amount of \$33,730. A portion of the 2025 Patterson Grant supported Match Day 2025, with remaining funds designated for future Match Days and community projects.

Many Foundation funds use Match Day resources to advance projects that benefit the community. In 2025, the Foundation supported several notable initiatives:

- A \$10,000 contribution helped launch the Frankfort Jane's Downtown Lighting Project in the fall of 2025.
- The Foundation hosted its annual appreciation luncheon at the Frankfort Nutrition Site, covering the cost of the meal and providing donated items distributed through drawings.
- A Community Appreciation Day was held during a February basketball game, offering free admission and popcorn to community members and serving as a distribution opportunity for the Foundation's annual report.
- The Foundation also funded the replacement of a commercial sink and repairs to fixtures at the Frankfort Nutrition Site, a key facility serving seniors and the broader community.

These projects reflect the Foundation's ongoing commitment to supporting programs and initiatives that strengthen the Frankfort community. We look forward to continuing this work in 2026.
